**11. Order for registration/approval:**

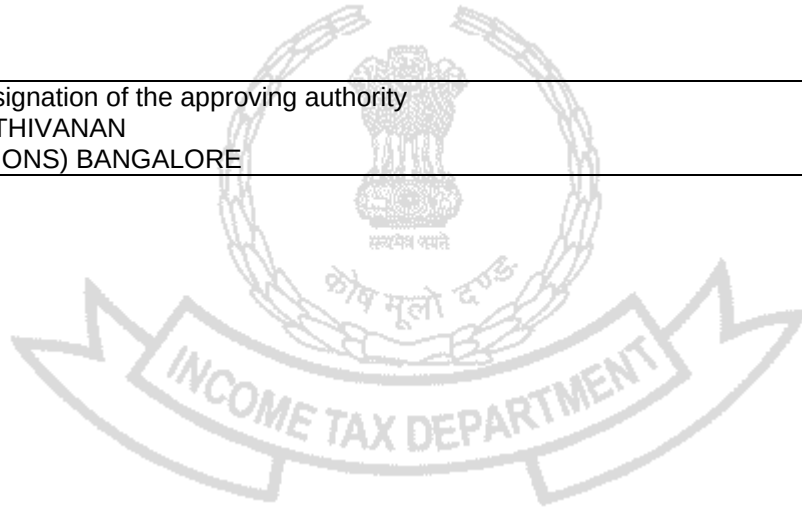
